

Vulnerable Senior Finds Help at Interfaith, by Yanique Duff-Ballard, Case Manager

She was waiting on a bench with some other clients when I first saw Ms. Jones. An unfamiliar face, she was an elderly, African American woman - she looked tired and distressed. I approached her and asked if she was okay, to which she replied, "Yes, I'm waiting for my husband to pick me up." But the next day, I saw her again, wearing the same clothes.

Lately, we've seen an increase in homeless elderly people. It is hard enough being homeless, but being homeless, elderly and trying to survive in this heat, is a nightmare. So in this case, my alarm bells went off.

I approached her once again, and tried having a conversation with her, but Ms. Jones got very upset and defensive, so I left her alone praying, tomorrow is another day and another opportunity to build a rapport with her. Sometimes that's what we have to do. After 3 days of her being around, my boss, Director of

Ministries, Jessica Vega, was able to have a conversation with Ms. Jones and realizing she had nowhere to go, so we were able to take her into the shelter. We could tell Ms. Jones had some memory problems and was in dire need of help. At 69 years old, she was run down, tired and confused. We were happy we could take her into the shelter.

The first few days, Ms. Jones slept most of the day. We were grateful she was able to get some much-needed rest. After that, she started coming around, hanging out with the other residents getting acclimated to her new environment. In the meantime, Shelter Manager Michelle Collier started conducting an in depth background check to try and locate any family. For 2 weeks, the Shelter Team was able to care for Ms. Jones - such a sweet, yet vulnerable soul, you can't help but love her. We learned she was a retired bus driver from Detroit and we were able to locate her family and she was reunited with them. We learned that Ms. Jones lives in an assisted living facility for individuals with memory issues. She was sent to the hospital and upon her release, she didn't know where to go. She ended up being trespassed from a local business and later arrested for trespassing on said property. When Ms. Jones got released from jail, by the grace of God she found her way to Interfaith. I believe God led her to us! Thank you Jesus for this wonderful shelter as we were able to keep her safe until she could get back home. When we took Ms. Jones in, we didn't know how it would work out. But we believed in God and we knew if He brought her here, He would equip us to carry out the task.

As a donor - you helped create this happy ending. Every dollar that's donated keeps our lights on, our staff paid, and resources available to make a difference in each life we impact. Thank you for supporting our shelter and other vital ministries. God bless you all.

ID Program is Building Block for Better Opportunities, by Andrea Jordan, Social Serv Mgr

Interfaith has so many resources to help our community, and one I wanted to share about this month is our ID program. With the assistance of the Marion County Tax Collector's Office, Interfaith provides vouchers for our homeless community to obtain Florida Identification Cards. The importance of this program is enormous and helps in so many ways; applying for jobs and housing, opening a bank account, securing government assistance, seeking medical attention, and getting necessary medication. A big population that benefits the most from these ID cards, are those from our jail system. For those that are incarcerated, once released, having an ID is critical.

So far this year, we have provided 531 Marion County homeless residents with these ID's. There have been numerous occasions when someone that's received a voucher comes back to my office smiling ear to ear showing me their ID. They are so happy and grateful and it's by the grace of God we can provide such a necessary service.

These vouchers also highlight another great community partnership from George Albright and his amazing team at the Tax Collector's office. It's just one more way that working together with our community helps our community.

Summer is in full swing and while we don't have as many fund-raisers or other events during these months, it's a good time to consider other ways to support your favorite non-profit. Years ago, Interfaith Emergency Services had a sister foundation. When Monroe Regional Hospital sold to another company, Hospital Corporation of America made a \$1,000,000 donation to our Foundation! (Thank you again, to Mike Mangan and John Kurtz for making this possible). In 2017, the Foundation merged into Interfaith, and this endowment fund is now overseen by the Interfaith Board of Directors. These funds are invested in a managed account with Morgan Stanley and year after year contribute to our annual operating budget. This also allows us to accept donations of stock or other investments! Here are some other ways that you can support Interfaith for consideration.

LIFE INSURANCE

When the original purpose for a life insurance policy no longer applies - such as educating children now grown or providing financial security for a spouse now deceased - your policy can become a powerful and simple way to support our work. There are three ways to give life insurance to Interfaith Emergency Services:

Name us as beneficiary of the policy. This gift is as simple as updating your beneficiary designation form with the insurance company. You can designate us as the primary beneficiary for a percentage or a specific amount of the death benefit. You can also make us the contingent beneficiary so that we will receive the balance of your policy if your primary beneficiary doesn't survive you.

Make an outright gift of an existing policy. You can name us as the owner and beneficiary of an existing policy. You may receive a federal income tax charitable deduction and reduce your future estate tax liability. If you continue to pay premiums on the policy, each payment is tax deductible as a charitable gift.

Make an outright gift of a new policy. You can take out a new policy and irrevocably name Interfaith Emergency Services as the owner and beneficiary of the insurance contract. This may involve ongoing premium payments by you or a one-time lump sum payment - each payment is tax deductible as a charitable gift.

Happy Summer! One of my favorite things about this time of year is being able to reflect on the first half of the year and see how much we have accomplished and then be able to set goals for the second half of the year based on those accomplishments. In the first six months of the year, the Engagement Center has been able to provide 1,021 services to 641 households in Marion County. We were able to help 44 individuals with positive housing movement and helped another 16 individuals secure full-time employment. Those services were provided by only 1 staff member and 3 faithful volunteers: Brian, Dani, and Robert. Imagine the increase in the number of lives being changed when we increase our volunteer capacity. I would love to see those numbers double, or even triple by the end of the year, and that is possible with your help.

If you are looking for a way to give back and have some extra time, please consider the Engagement Center. We are looking for 30 volunteers to join us when we open in August, but we plan to start training our new volunteers in July. Nothing compares to the joy of helping the hopeless find hope.

I have worked in the Food Pantry as a volunteer since November. Not officially "retired" yet, but having a much freer schedule, I decided to apply to Interfaith as a volunteer. After Tina gave me the tour and asked what area most interested me, I chose the Food Pantry. Because you see, that is where I met Interfaith for the first time back in 1989-1990. I had just graduated college and had been searching for a teaching job to no avail. I did have a car and an apartment.
