

## Single Mom Finds Hope at Interfaith's Shelter, by Sonya Tyler Director of Operations

Faced with being a single mom, with a baby on the way, Molly had nowhere to go. It seemed that life was crushing her under its thumb with one disappointment after another. After losing her husband, job and apartment, Molly found herself on Interfaith's doorstep in 2008, with nothing more than a few belongings and her 3 year old daughter, Megan.

Lucky for Molly, Interfaith was set up with her situation in mind. Our homeless shelter has always been a refuge in the storm for many people through the years, and thanks to the donors that support us, our first step is providing a safe, stable environment for those in need.

For Molly, being 6 months pregnant made her life even more challenging since she was unable to work, and had no one to help care for her little one. Molly said, "When you are at your lowest point in life, you realize how blessed you have been, and how far back it is to what you once had." Molly went on to add, "I tell people my time at Interfaith was the worst and best part of my life, which people have a hard time understanding. Being homeless with my daughter, and pregnant with my son, I was definitely at my lowest point, but I've also never seen such compassion and love as when I was in the (Interfaith) shelter. The people cared about me and wanted to help me. I'll never forget that."

I learned about Molly from a message she left on Interfaith's Facebook account, where she posted how grateful she was to Interfaith for helping her in her greatest time of need. When we talked on the phone, Molly said it was actually the staff at Interfaith that encouraged her to have her daughter tested, where she learned Megan was autistic, and she was able to get help for her. "I stayed with Interfaith long enough to have my son Kaleb, and work towards getting my own place. Interfaith helped me get an apartment after Kaleb was born, and even provided me with some furniture and food – I was so grateful to be given a fresh start," Molly said.

Today, Molly is back with family in Orange Park. She has a good job and loves spending time with her kids – Megan (now 12 years old) and Kaleb (9 years old). Molly loved the idea of sharing her story in our newsletter, and wanted to let everyone know what a blessing it was to her and her children, that Interfaith was here for her.

Thanks to the faithful donors that support Interfaith financially, we were here for Molly in 2008, and today – we're here for Jamie, Susan and countless others that are in need. Thank you for giving so that others can change the lowest point in their lives, to one of hope.

## LIFE INSURANCE

When the original purpose for a life insurance policy no longer applies—such as educating children now grown or providing financial security for a spouse now deceased—your policy can become a powerful and simple way to support our work. There are three ways to give life insurance to the Interfaith Foundation:

Name us as beneficiary of the policy. This gift is as simple as updating your beneficiary designation form with the insurance company. You can designate us as the primary beneficiary for a percentage or a specific amount of the death benefit. You can also make us the contingent beneficiary so that we will receive the balance of your policy if your primary beneficiary doesn't survive you.

Make an outright gift of an existing policy. You can name us as the owner and beneficiary of an existing policy. You may receive a federal income tax charitable deduction and reduce your future estate tax liability. If you continue to pay premiums on the policy, each payment is tax deductible as a charitable gift.

Make an outright gift of a new policy. You can take out a new policy and irrevocably name the Interfaith Foundation as the owner and beneficiary of the insurance contract. This may involve ongoing premium payments by you or a onetime lump sum payment—each payment is tax deductible as a charitable gift.

## A Quiet Whisper, by Steve Clem, Warehouse Manager

Several months ago I walked into the Warehouse early one morning and it was nice and quiet. As I started flipping on lights and setting up for the day, I could have sworn I heard a whisper. I was certain I was hearing things, but then I heard it again. It said, "Feed me."

Now at the time, our Warehouse was pretty empty, and we were worried we wouldn't have enough food to reach all of our clients throughout Marion County – including our local pantry here in Ocala, and other satellite pantries in Ft McCoy, Fellowship, Reddick, Marion Oaks and Pedro. Our demand was greater than the empty shelves could provide.

Our staff went into action – reaching out to the community for help. And we knew that if we trusted in God, the community would come through for us – and they did, in a big way. Local churches, businesses, groups and individuals started doing food drives, and the pantry started to fill again. By the time the annual Letter Carrier's Food Drive came around in mid-May, we were blessed with over 113,250 pounds of food! Today, we picked up from the Marion County Tax Collector's office, where the food drives from all their offices collected 18,000 pounds of food, for both the Warehouse and our Food 4 Kids program.

Now, I haven't heard anymore whispers, but if I do, I'm sure it will be... "thank you!"

At the Center for Life, business is booming! Everyday we seek to fulfill our mission to be “a community of faith called by God to offer emergency assistance without judgment to all persons in Marion County”. In order to accomplish this, we have several programs up and running, with more coming soon! Here’s a brief overview...

We have three prescription programs: the Emergency Prescription program, the PAP program (Patient Assistance Program), and the HDG (Hospital District Grant) prescription program for those with diabetes and/or mental health issues. Also, we are now partnering with community health education providers. The goal is to include education about all aspects of healthcare, and to start, we are focusing on our diabetic clients. Our first Diabetes Management class began on Tuesday, June 6th run by Dynamic Therapy & Wellness Services. This course is held on Tuesdays at 3:00pm and is open to anyone wanting to prevent, manage, and reduce the effects of diabetes.

Finally, we are excited to share that we are now launching our newest program at the Center for Life - the Patient Sustainability Assistance Program or “PSAP”. This is a program designed for volunteers (Health Advocates) to work closely with clients and provide case management for medical needs. Clients receive one on one attention and are mentored through the application process for benefits such as Medicaid and SSDI. The volunteers serve as coaches to encourage clients as they become more educated and self-sufficient in terms of their own healthcare. We are praying that God will enable us to help others in a tangible way in order to show His love!
